11. Herefordshire Minerals & Waste Local Plan Main Modifications Consultation The Parish Council is notified that the Minerals and Waste Local Plan (MWLP) is currently being examined by Government-appointed Planning Inspectors.

In November 2022, hearing sessions were held. Following this the Inspectors recommended several amendments, as set out in a Schedule of Main Modifications and Minor Changes. The Main Modifications are considered necessary to make the Plan 'sound'. An 8-week public consultation on the Main Modifications and their associated Sustainability Appraisal (SA) and Habitats Regulations Assessment (HRA) reports, is taking place between 26th June and 21st August 2023.
