Minutes of the Ordinary Council Meeting held on Monday 29th January 2024 at 7:00pm, at Edwyn Ralph Village Hall

The Clerk reminded all members to check whether their Register of Interests are all up to date with Herefordshire Council.

1. To receive, consider and approve apologies for absence All members present.

2. Declarations of Interest and written Requests for Dispensations

3. To receive and approve the minutes of the previous meeting.

It was RESOLVED to confirm as a correct record and sign the Minutes of the Parish Council meeting held on Monday 27th November 2023.

4. Open Session: (10 Minutes)

- 1. Update from Ward Councillor Baker of Herefordshire Council (HC)
 - Highways drain clearance Cllr Baker understands that the vehicles used to clear roadside drains operates out of Birmingham. He is looking into the current contract arrangements to see if this is the case.
 - Police Crime Commissioner grant funding available to local councils for roads safety.
 - Meeting with the Assistant Police and Crime Commissioner Cllr Baker attended an interesting meeting earlier in the month at Puddleston Village Hall, attended by 6 representatives from the Hampton Ward.
 - National Highways (NH) Cllr Baker recently met with representatives from NH to discuss local road safety issues, specifically for the A49.
 - Children's Services performance is steadily improving. Services will remain under HC's control. HC is working with Leeds City Council to make further improvements.
 - Recent flooding 66 properties in Herefordshire suffered internal flooding. Residents affected are advised that financial and physical support is available from several agencies.
 - Norovirus cases of this highly infectious illness are increasing in Herefordshire.
 - The Three Counties Hotel asylum seekers based at the hotel are being relocated by the relevant authorities.
 - Recycling Centres permit holders (for trailers) are advised that digital permits will be introduced from April.
 - HC budget 2024/25 proposed Council Tax increase of 4.99% will be approved at a HC budget meeting on 9th February 2024.

Cllr Baker was asked if the Morton Meadows car park site in Hereford was going to be redeveloped into housing. Cllr Baker was not aware of any plans and would report back at the next meeting.

To receive representations from the Public on parish matters
 A member of the public asked for an update from the Edwyn Ralph Neighbourhood Development Plan Steering Group.

Cllr Ede confirmed that following the successful outcome of the local referendum to adopt the NDP on 16th February 2023, no further meetings of the Steering Group are required at this stage.

5. Finance

- a. Members received a financial report and considered any actions as required (Appx. 1 refers)
- b. Members considered and approved the Budget and set the Precept 2024/25 (Appx. 2 refers)
- c. Members considered the NJC recommendation for increase in staff salary scale and agree action as required. It was RESOLVED to defer consideration of this item to the next meeting.
- d. Members considered rejoining Herefordshire Association of Local Councils for 2024/25. It was RESOLVED not to renew the Council's subscription for 2024/25. This will be reviewed annually.
- e. Members considered and approved a list of invoices for online bank payment. **It was RESOLVED** to approve the following list of payments, as below.

6. To consider comments on Planning Applications for determination by HC

a. <u>P233520/U:</u> Meadow Gate Farm, Thornbury, HR7 4NJ. Certificate of Lawfulness (CLEUD) Occupation of Meadow Gate Farm (Formerly Upper House Farm), Thornbury in breach of the Agricultural Occupancy Condition for a continuous period in excess of 10 years which continues at the date of the application.

It was RESOLVED to note this information.

b. <u>P240022/FH:</u> Bramblewood, Edwyn Ralph, HR7 4LY. Proposed revision of rear elevation to be extended by approximately 1.8M and incorporate new bi-fold doors. **It was RESOLVED** to SUPPORT this application.

7. Parish Defibrillators: Members received an update and considered actions required.

- a. Edwyn Ralph: Cllr Edwards is continuing to carry out regular checks of the machine and reports her findings online, directly to The Circuit.
 - It was RESOLVED for the Clerk to contact The Heartbeat Trust to arrange community training, as per the purchase agreement.
- b. Collington: Cllr Farrant arranged the installation of the new machine, on the church wall in Collington. He has now registered it with the national Circuit network.
- c. Thornbury: Members decided community funding raising or a grant would be required for the purchase of a new machine.

8. Highways issues: to consider any issues to report to HC, the Highways Authority.

- a. To consider the West Mercia PCC Safer Roads Grant Round 2 Launch. Members noted the information received. Councillors were unable to consider the grant details in full as the closing date was in the coming days. Unfortunately, the information had been delayed as it was delivered to the Clerk's 'junk' email folder.
- b. B4214: from Bromyard to Edwyn Ralph Members expressed serious concerns at the condition of the road, which is very degraded in parts, with large potholes, worn line markings and crumbling, rutted edges.

It was RESOLVED to report the Parish Council concerns directly to HC for action. Ward Cllr Baker also agreed to report this matter on behalf of the parish. Residents are also welcome to report their concerns about this issue to HC.

Thornbury Group Parish Council Precept 2024/25

How is the Precept Calculated?

The Precept is a tax that Parish Council's charge their local electors to meet their budgetary requirements.

Parish Councils do not receive any direct funding from central government and rely on their Precept, plus any other income they generate from services or facilities they provide. The Parish Council Precept is part of the Council Tax and is collected from local electors via their Council Tax payments, it requests this funding from its 'local billing authority' – in our case, Herefordshire Council. The Parish Council is required (in law) to agree a budget before it can set its Precept."

Thornbury Group Parish Taxbase = number of Band D properties in the parish

- > Tax base 2023/24 = 196.73
- \rightarrow Tax base 2024/25 = 195.09

Precept calculations based on number of Band D properties in the parish

- Proposed Precept £6,000
- ➤ This would mean an approximate increase of 10% per Band D properties
- \blacktriangleright Band D tax 2024/25 = £30.76 (additional £2.80 per Band D from 2023/24)
