1. ELECTION OF CHAIR

1.1 It was unanimously **RESOLVED** to elect Cllr. Ashley Ede as Chair. Cllr. Ede duly signed his Declaration of Acceptance of Office.

2. ELECTION OF VICE CHAIR

2.1 It was unanimously **RESOLVED** to elect Cllr. Kitty Edwards as Vice Chair.

3. APOLOGIES

Apologies were received from Cllrs T Edwards, J Farrant, H Lewis, P Wildig, and Ward Cllr B Baker.

4. DECLARATIONS OF INTEREST

- 4.1 Register of Interests Members noted the need to update their Register of Interests.
- 4.2 To declare any Disclosable Pecuniary Interests (DPI) and other interests in items on the agenda as required by the Parish Council's Code of Conduct for Members and by the Localism Act 2011. 5. MINUTES OF THE PREVIOUS MEETING

5.1 It was unanimously **RESOLVED** to approve and sign the minutes of the meeting held on Monday 25th March 2024 as a correct record.

6. CO-OPTION

6.1 To fill one remaining vacancy via co-option for Thornbury.

It was **RESOLVED** to co-opt Mr William Keown-Boyd as a new member that will represent the residents of Thornbury.

7. PUBLIC SESSION

7.1 Public questions for parishioners.

Potholes / Footpaths: residents raised their concerns regarding the overgrown state of some parish public footpaths and ongoing issues with potholes.

- PROW (Public Right of Way) ER6: very overgrown and difficult to walk.
 It was RESOLVED to report this to HC.
- Drainage gully, near the track by the village hall, is full. Run off is originating from HC property and blocking two further gullies which leads to erosion of the lane and more potholes.
 - It was **RESOLVED** to raise this with Ward Cllr Baker.
- Potholes safety concerns at the state of the B4214, from Bromyard to Edwyn Ralph, particularly near to the Rowden Abbey turn off. The Local Highways Authority (HC) have recently spot filled some of the deepest potholes, however, the condition of the road is still unsatisfactory.
 - It was **RESOLVED** to monitor the condition and to report and new or developing potholes to HC.
