It was **RESOLVED** to defer this item to the next ordinary meeting as most members present were not at the July meeting.

25/17 WARD COUNCILLOR UPDATE

Ward Councillor Bruce Baker provided the following update.

- Hereford Bypass – HC Cabinet has agreed the next steps in delivering the first phase of the bypass.
- Neighbourhood Development Plans (NDPs) – Central Government funding has been withdrawn; communities must now self-fund the creation or revision of NDPs.
- Call for Sites – HC has launched an evidence-gathering exercise to identify potential land allocations for the new Local Plan.
 - This will shape future housing, employment, infrastructure, and environmental improvements across the county.
 - Submission of a site does not guarantee allocation but ensures options are considered in long-term planning.
- Annual Electoral Canvass – Now underway to maintain the accuracy of the electoral register.
 - All households must confirm registered voters or report changes.
 - HC will prioritise data and electronic communication (email/text) before issuing hard copy letters to reduce costs.
- NMITE – The first students have graduated from the New Model in Technology and Engineering (opened in 2021)

25/21 VILLAGE HALL UPDATE

Members noted that the Village Hall Committee has appointed a new Chair, Mrs Tracy Meadows. Mr Ian Meadows was co-opted to join the committee.

It was agreed that Cllr Kitty Edwards be appointed to the vacant position of Parish Council Representative, to serve alongside Cllr Ede.

25/22 HIGHWAYS / FOOTPATHS / TRAFFIC

Members noted the following information.

- Public Rights of Way (PROW) – (*Ref. agenda item 25/11*): At the previous meeting, a resident reported that several parish footpaths crossing arable land were sometimes difficult to use, owing to their narrowness caused by adjacent planting. Cllr Ede subsequently met with the resident to identify the affected areas on a map of the parish. It was noted that dry conditions, together with ruts and furrows, are making the paths harder to navigate. The situation will be monitored to determine whether conditions improve with a change in the weather.
- Resurfacing works at Streetfield – 28 to 29 August (8am – 5pm).
- Highway signage – members are asked to report overgrown signs to the Clerk.
